

Foreign nationals are strictly limited in what sources of income they are authorized to accept. The University <u>cannot</u> issue payment to a foreign national unless the following criteria and documentation requirements are met. All payments are subject to tax withholding unless an exemption exsists under a U.S. tax treaty or Internal Revenue Service code.

The most common visa types are **B1**, **VWB**, **F1**, and **J1**
